AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of West Valley School District No. 208 from September 1, 2016 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Use of restricted funds professional learning
- Establishment of local revenue and expenditure accounts
- Accounts payable general disbursements, credit cards and electronic funds transfers
- Compliance with public works projects, purchases, and professional services
- Self-insurance for unemployment and workers compensation
- Payroll leave cash outs, overtime and compensatory time
- District vehicle use
- Student enrollment reporting basic and Alternative Learning Experience (ALE)

INFORMATION ABOUT THE DISTRICT

West Valley School District No. 208, located in Yakima County, serves approximately 5,300 students in pre-kindergarten through 12th grade. The District provides a full range of school programs and services including basic elementary, middle school, high school, vocational education, bilingual education, pupil transportation, food services, special education and numerous special programs for remedial and enriched education. The District operates 10 schools including a high school, freshman campus, junior high school, middle school and six elementary schools.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 328 certified and 213 classified employees. The District operates on an approximate \$60 million annual budget.
